Download format of the statement

Downloading statements via the e-payment service form is filled out in case the user wants to download statements on changes and the balance in the transaction account through the e-payment service. Statements via the e-payment service are provided at the account level and all users who have rights to the same account have the opportunity to view and download the statements. The fee is calculated based on the account for each selected statement format according to the price list of the bank at which the transaction account has been opened, and the fee is recorded regardless of whether the user downloads the statements regularly or not.
